Terms of Service

TERMS OF SERVICE

ACCEPTANCE OF TERMS

XMind, Ltd. (referred to herein as “We” or “XMind”) welcomes you to this website (collectively, including all content and technology available through the XMind.net and XMind.org domain names, the “Site”). These Terms of Service apply to all users of the Site, including users who are contributors (“Submitters”) of files, content, information, and other materials on, or made available through, the Site (“Submissions”). The Site includes all aspects of XMind, including but not limited to all products, software and services offered via the Site such as XMind Pro, the XMind Widget, and XMind Share.

By using and/or visiting the Site and/or linking to any file residing on any other site that is accessed via the Site, you give your assent to both these Terms of Service and to XMind’s Privacy Policy (<http://www.xmind.net/privacy.html>), which is incorporated herein by reference.

We reserve the right to modify or revise these Terms of Service in our sole discretion without notice, and you agree to

be bound by such modifications or revisions.

If you do not agree to any of these terms, then please do not use the Site.

XMIND ACCOUNTS

In order to access some features of the Site, you will have to create an XMind account. You may never use another's account without permission, and you may never use another's account ID to access fee-based products and services, including but not limited to XMind Pro software subscriptions, for which you have not paid. When creating your account, you must provide accurate and complete information. You are solely responsible for the activity that occurs on your account. You must notify XMind immediately of any breach of security or unauthorized use of your account.
